


- 2016: 250 million VAP and 138.8 million turnout (55.5%)
- 270 out of 538 Electoral Votes = 46th President
- 35 out of 100 Senate seats contested (12 D and 23 R)
- 435 House seats contested (Today 235 D and 198 R)
- 13 Gubernatorial elections (11 states and 02 territories)
- 86 out of 99 State Legislative Chambers (House / Senate)
- 5,876 of the 7,383 state legislative seats disputed
- 82 state supreme courts seats contested in 35 states
- Referenda, 35 mayoral elections, Native American ...
- Redistricting...






### **Commercial Balance: Brazilian and U.S. Exports**




### **Commercial Balance: "Trump" gains**



### **Commercial Balance: Brazilian losses**




### **Commercial Balance: China Factor**



### **Total FDI in Brazil: Entry and Exit**




### **Diplomatic Relations: Presidential Visits**







- IDB presidency: United States broke tradition
- Negative impact of U\$1.6 billion to Brazilian exports
- Additional tariffs to steel and aluminium
- 2 million chloroquine doses purchased

- Visa waiver for American tourists
- Abdication of the Differential Treatment from WTO
- Increase in the Brazilian imports of ethanol and wheat
- American use of the Alcântara Space Launch Base

# UNCERTAINTIES

#### **5G**

Bolsonaro's unwillingness to accept China's participation in the 5G. Brazilian MoU with EximBank foresees the financing in the area of telecommunications, specially the implementations of 5G internet network. Would Biden continues to damage U.S. - China Relations?

#### **Climate Change and the Amazon Region**

Bolsonaro was instrumental to the increase of Amazon deforestation. The emblematic dialogue with Al Gore during The World Economic Forum (2019): "The Amazon cannot be forgotten. We have a lot of wealth and would like to explore it with the United States"...

# UNCERTAINTIES

#### COVID-19

Bolsonaro's utter rejection of the lethality of the virus, as well as his refusal to adopt measures such as social distancing and mandatory use of masks. Similar stance that Trump took... Brazil is still deep embroiled in a sanitary, economic and political crisis. Stark differences between Trump and Biden in this crucial aspect.

#### "Anti-Corruption"

The discourse that Bolsonaro election would be the end of "old politics" has over and over again proven false. Scandals concerning his family have arisen and Bolsonaro tried to block investigations. Recently, Brazil and the U.S. signed a commercial agreement that foresees "action against corruption". Biden more in favour of Lava Jato (Car Wash)? Would that be good for Brazil?
